(i) That I have read all the provisions of the NCTE Act, Rules & Regulations. The application of the institution has been submitted as per the provisions of the NCTE Regulation 2009. That the Institution of the management shall be run under self finance scheme

(ii) That the society/trust is eligble as per the clause 4 of the NCTE Regulation 2009

(iii) That the institution is in possession of legally vaild land documents and conversion of land has been obtained form the compentent authority as per the provisions of the law of the concerned State.

(iv) That the institutions has constructed building on the legal vailed land possessed by the institution as per provisions of the NCTE regulations. The construction of the building is complete in the form of a permanent structure. There is no temporary struture or asbestoses roofing.

(v) That the institution undertake that the building of the institution is constructed keeping in view the provisions and by laws of the building construction as per the bureau of standards and the same is fully safe and secure to run the teacher training course. The safeguard against fire hazard has been provided in all parts of the building. The institution has submitted the building comletion certificate as per the prescribed format.

(vi) That in addition to the above the infrastructural, instructional and other facilities are provided as per the NCTE Regulations, norms Standards and guidelines prescribed from time to time

(vii) That admission to the course will be made only after recognition is granted by the concerned Regional Committed of the NCTE and affilation is granted by the concerned University/ Affilating body.

(viii) That admission of student, satisfying eligibilty conditions shall be made on merit on the basis of marks obtained in the qualifying examinations and/or in the entrance explination or any other selection process as per the policy of the state Government/U.T. Administration and the University.

That there shall be reservation of seats for SC/ST/OBC other categories etc. as per policy of State Govt.

- (x) That the supporting and other staff will be appointed as per the guidelines of the state Govt./the affiliating University.
- (xi) That the institution shall charge only such fee, as prescribed the affiliting body/ State Govt. concerned in accordance with provision of NCTE (guidelines of Regulations of tuition fees and other fees chargeable by unaided teaher education institutions ) Regulations, 2002, as amended from time to time and shall not charge donations, capitation fee etc. from the students.
- (xii) That the academic and other staff of the institution (including part time staff) shall be paid such as salary as may be prescirbed by the concerned state Govt/University from time to time through bank.
- (xiii) That the Management shall discharge the statuory obligations relating to provident fund, pension, gratuity etc. in respect of all its employees.
- (xiv) That the Management will make adequate funds available for providing satisfactory facilties and for proper programme implementation.
- (xv) That the accounts of the institution will be properly maintained and audited annually by the audit authorities or a chartered Accountant, and will be open for inspection.
- (xvi) That the Management will strictly follow all conditions and norms prescibed by NCTE from time to time, conduct the programme in all earnestenss, and submit itself to inspection by the NCTE.
- (xvii) That the institution shall make the infomation or documents available to the NCTE or its authorized respresentatives as and when required by them. Failure to produce or show any of the required documents shall be treated as a breach of the conditions of recognition.
- (xviii) That the institution shall maintain records or registers and othre documents etc. which are essential for running of an educational instition especially those prescribed in the relevant norms and standards and guideliness or instructions or rules etc of the central or state or union Territory Governments, affiliating or examining bodies.
- (xix) That the institution shall adhere to the mandatory disclosure in the prescribed format and display up to date information on its official website.
- (xx) In the event of non- comliance by the Shaheed captain D.K. Khola College of Edcuation, Dineshpur with regard to the norms and standards and any other condition laid down/ prescribed by the NCTE from time to time, the NCTE or a body or a person authorized by it will be free to take all necessary measures for effecting withdrawal of its recognition or permission, without conisderation of any other issue and that all liabilities arising out of such as a withdrawal would solely be that of the institution Manegement

(xxr) That the Management will not cause or allow discontinuation of the course in any year or for any batch, and that where compelled, it will seek the concurrence of NCTE for discontinuation on the compeltion of the year/batch.

(xxii) The Shaheed captain D.K. Khola College of Edcuation, Dineshpur by virtue of the apporval given by the NCTE shall not automatically become claimant of any financial grant or assistance from the central or state Govt or supprot from the NCTE.

(xxiii) That the Managing committee of the instituions has been formed as per the guidlines of the state Govt/ affilitiing University.

(xxiv) That the management undertakes to submitted perfromance appriasal report regular as per provisions of the NCTE Act Rules & Regulations.

That I do hereby swear that the above declartions/statements containing from point (i) to (xxiv) are true and correct to the best of my knowledge & belief and it conceals nothing and that no parts of this is false. In case the contents of undertaking are found to be incorrect or false, I shall be liable for action under the relevant provisions of the Indian penal code and other relevant laws.
